## **ABOUT THE PROGRAMME**

MNLU Mumbai has floated LL.M. (Professional) a one year program and invites application for admission. LL.M. (Professional) Programme is unique and tailored meet the needs and to expectations law professionals who want their knowledge upgrade personal professional reasons, or are unable take a regiourus to residential LL.M. program. Programme and Courses are devised to benefit and advance careers of law professionals.

#### **ELIGIBILITY:**

The LL.M. (Professional) Programme will be conducted through a mixed mode of class room teaching & virtual contact learning. A person who has completed his/her LL.B. (3 years or 5 years) and has been in service or had professional experience will be eligible to enroll for the said programme.

#### **BENEFICIARY OF THE PROGRAMME:**

Litigation lawyers, Consultants, Judges, Law Teachers, Attorney, Journalists, Legal Professionals in Firms, Companies, Banks, PSU, MNC, NGO, etc.

The aim is to (a) impart Specialized Legal Training functioning of law, compliances, Practices, Procedures etc. (b) provide students with multidisciplinary exposures various laws of relevance contemporary. The lectures shall delivered by experts, experienced and renowned practitioners, judges, academicians professionals. The Programme is helpful to those preparing for competitive exams like JMFC, Public Service Commission's etc. This degree may be considered for the purposes of internal growth by respective organizations as per their internal policies. #### TOTAL NUMBER OF SEATS

The total numbers of seats are 100. However, the University reserves the right to alter the number of seats for the programme in a given academic year without prior notice.

#### **ADMISSION CRITERIA**

Candidates for admission will be selected on the basis of percentage secured in LL.B. The merit cut-off list will accordingly be prepared for admission. Reservation is as per Maharashtra Government Rules.

NOTE: LL. M. (Professional) shall not qualify a candidate to the academic benefits of regular LL.M. degree like admission to M.Phil./Ph.D. It shall not provide eligibility for NET/SET Exams.







#### **COURSE OUTLINE**

The LL.M. (Pro) Curriculum will have the following components:

- Compulsory and Elective Papers (4+4 course and each course has 2 credits)
- The Compulsory Course consisting of the 4 Papers and Elective Course consist of 4 papers which should be completed in the first and Second semester respectively.

#### **CREDITS**

The Programme will be of Sixteen (16) Credits comprising of:

- Four mandatory papers of two (2) credits each
- Four Elective papers (2) credits each

#### **DURATION**

 The programme will be for a period of one academic year. The academic year will run from August 2021 to July 2022. The intense academic activity during each semester will be spread across 18 weeks and it shall include teaching, project assignments, seminars etc.

# EXAMINATION SCHEME

It shall be mandatory for every student for every examination appear conducted by MNLU MUMBAI. There shall be end term exam conducted at the end of every semester. A student who himself/herself absents for examination shall be declared "Failed" in that course. He/she shall appear in Examination for that course, when conducted the next time. If he/she passes the course in the next attempt, obtained shall the grade have mentioned against it in the transcript. For removal of difficulties the Vice Chancellor, on the recommendation of the Committee to be constituted by the Vice Chancellor, shall have power to make such modifications, alterations or amendments in as may be necessary which shall be approved from relevant bodies.

#### **ATTENDANCE**

- The LL.M. (Professional) Programme

  virtual contact learning. Attendance
  in the contact classes is an
  important component of the
  programme. It is expected that
  students shall attend the scheduled
  contact classes.
- Every student has to secure minimum of 50% attendance in all the subjects taken individually in each Semester to be eligible to **End-Semester** in the appear examination. Student, who short of requisite attendance, shall not be permitted to take the end of course/ end Semester the examination.
