1. **Dr. Aman Hingorani** - *Advocate-on-Record and Mediator, Supreme Court of India and Author*

Dr. Hingorani was called to the Bar in 1992 and has been imparting advocacy skills training since 1998. He has delivered courses at institutions in India (such as Indian Law Institute, New Delhi; Delhi University and several national law schools) and abroad (such as Keble College, Oxford; Warwick Law School and South Asian Institute of Advanced Legal and Human Rights Studies, Dhaka). Dr. Hingorani has authored the SAGE bestseller, *Unravelling the Kashmir Knot*, apart from another 35 national and international publications.

2. **Ms. Mishika Singh**, *Advocate, Delhi High Court*

Ms. Singh holds a degree in law and in journalism as also a PG diploma in Intellectual Property Rights, and has been engaged with advocacy skills training. Her current area of law practice is civil litigation, arbitration and family law. Ms. Singh conducts workshops on the rights of women in India with various NGOs in Delhi, and is also working in the field of Sexual Health and Human Rights of unmarried women with Haiyya Foundation.

3. **Mr. Chirag Balyan** (*Course Coordinator*)

Mr. Balyan is an Assistant Professor of Law at MNLU Mumbai and Additional Director at Lawlex Educational Trust. He teaches Legal Methods, Criminal Law and ADR at MNLU Mumbai.
