### Vacant Seats Admission Instruction

**The allocation of vacant seats shall be done strictly according to the All India Rank (AIR) merit, for the respective categories without any exceptions or deviations.**

Please follow these instructions carefully to ensure a smooth application process.

#### **A. All India General Category: LL.M program.**

Candidates with an All India Rank (AIR) between 1501 and 2200 are eligible to apply for admission to the LL.M program.

A.1 There is no limit on the All India Rank (AIR) for candidates applying under the Maharashtra Reserved Category (MH-DTA and MH-ST) for admission to the **LL.M program.**

A.2 we are pleased to announce the availability of seats in the following LL.M specializations:

**1. Constitutional Law - 4 seats available**

**2. Intellectual Property Rights (IPR) - 6 seats available**

Eligible candidates are invited to apply for these specializations.

#### **B. Instructions for Maharashtra Un - Reserved Category Applicants (B.A.LL.B)**

A single seat is available in the B.A. LL.B (Hons) program under the Maharashtra State Unreserved category. This seat is open to all candidates who possess a

Maharashtra domicile certificate. - Candidates with a Maharashtra domicile certificate - All India Rank up to 1200 are eligible to apply for admission to the B.A. LL.B (Hons) Program.

C. Candidates who had already applied vide Notification No. NLUM/ACD/02/362(1)/2024 dated July 2, 2025, are required to submit a fresh application for the newly notified vacant seat. Please note that a new application fee will be applicable.

D. Please note the category and eligibility criteria carefully before applying.

E. **Waitlist Operation:** In case of vacancies arising in the above categories at a later date, the vacant list will be operated to fill the available seats.

2. Candidates who have appeared for CLAT 2025 and are desirous of taking admission in B.A., LL.B. (Hons.) and LL.M at MNLU Mumbai under vacant categories should make an application in the above mentioned proforma (**Annexure-A**) expressing their interest in seeking admission for the academic year 2025-30.

  - ii. 10<sup>th</sup> Marksheet
  - iii. 12<sup>th</sup> Mark Sheet
  - iv. Maharashtra State Domicile Certificate (if applicable).
  - v. Maharashtra Caste Certificate and Caste validity certificate.
  - vi. Non-Creamy Layer Certificate (not required for MH-ST / MH-SC / MH-EWS category).
  - vii. Application fees receipt.
  - viii. LL.B Mark sheet and Certificate for LL.M Candidate.
  - ix. Aapar Id photo copy
  - x. Anti-ragging affidavit
4. Candidates are requested to pay prescribed fee of Rs. 1,000/- per application through PayTM towards application processing fees.
