### Vacant Seats Admission Instruction

**The allocation of vacant seats shall be done strictly according to the All India Rank (AIR) merit, for the respective categories without any exceptions or deviations.**

Please follow these instructions carefully to ensure a smooth application process.

#### **A. All India General Category: LL.M program.**

- All India General Candidates: 5 seats available for candidates with an All India Rank (AIR) of upto 5000.
- Maharashtra State Domicile Candidates (Unreserved Category): 2 seats available for candidates with an All India Rank (AIR) of upto 5000 and holding a valid Maharashtra domicile certificate.

#### **B. we are pleased to announce the availability of seats in the following LL.M specializations:**

- 1. Constitutional Law - 3 seats available**
- 2. Intellectual Property Rights (IPR) – 4 seats available**

Eligible candidates are invited to apply for these specializations.



**C. Instructions for Maharashtra State NTC Category (B.A.LL.B) (01 seat)**

1. One seat is available in the B.A. LL.B (Hons) program under the Maharashtra State NTC. There is no limit on the All India Rank (AIR) for candidates applying under the Maharashtra Reserved Category (MH-NTC) for admission to the **B.A.LL.B (Hons) program 2025-30.**

**D.** Please note the category and eligibility criteria carefully before applying.

**E. Waitlist Operation:** In case of vacancies arising in the above categories at a later date, the vacant list will be operated to fill the available seats.
