Vacant Seats Admission Instruction

The allocation of vacant seats shall be done strictly according to the All India Rank (AIR) merit, for the respective categories without any exceptions or deviations.

Please follow these instructions carefully to ensure a smooth application process.

1. Instructions for All India General Applicants

- For admission to **B.A. LL.B. (Hons)**, candidates in the **All India General Category** can apply only if their **All India Rank (AIR)** is upto **1500** (i.e., AIR 1-1500).
- For admission to **LL.M.** for the academic year **2026-27**, candidates in the **All India General Category** can apply only if their **AIR** is upto **2000** (i.e., AIR 1-2000).

2. Instructions for Maharashtra Reserved Category Applicants

- Vacant seats for Maharashtra reserved categories are available as shown in the table above.
- There is no limit on the All India Rank (AIR) for Maharashtra Reserved Category candidates.

3. **Waitlist Seats:** If any of the seats mentioned above become vacant at a later stage, they will be allotted to candidates on the waiting list in accordance with the prescribed admission procedure. Subject to applicable rules and eligibility criteria.

Application under any other mode will not be entertained.
2. Candidates who have appeared for CLAT 2026 and are desirous of taking admission in B.A., LL.B. (Hons.) and LL.M at MNLU Mumbai under vacant categories should make an application in the above mentioned proforma (**Annexure-A**) expressing their interest in seeking admission for the academic year 2026-31.
3. Copies of following documents shall accompany the application:
 - i. CLAT Application Form
 - ii. CLAT 2026 Score Card.
 - iii. 10th Mark sheet
 - iv. 12th Mark Sheet
 - v. LL.B degree marksheet and passing certificate
 - vi. Maharashtra State Domicile Certificate (if applicable).
 - vii. Maharashtra Caste Certificate and Caste validity certificate.
 - viii. Non-Creamy Layer Certificate (not required for MH-ST / MH-SC / MH- EWS category).
 - ix. Application fees receipt.

PLEASE NOTE:- After filling out the Google form, you are requested to merge all the above-mentioned documents into a single PDF file and email the same to admission@mnlumumbai.edu.in for verification and further necessary action.

4. Candidates are requested to pay prescribed fee of Rs. 1,000/- per application through PayTM towards application processing fees.
