The admission offered through this list is provisional and is subject to the following conditions:

- 1. Physical Verification of Documents:** Candidates must appear for physical verification of all prescribed original documents.

Failure to produce or submit the required documents during verification shall result in cancellation of admission without any further notice.

- 2. Refund Policy:**
