B.A., LL.B (Hons.) 2026 - 2031 and LL.M. 2026-27 Programme

IMPORTANT NOTE

Such shortlisted candidates need to upload to the below mentioned documents to the CLAT Portal. In case of any upload limit, the candidate must email the clear scanned copies of the documents to admission@mnlumumbai.edu.in with subject line ‘Documents – Name of Candidate – 1/2/3/4/5 Provisional List – B.A.,LL.B. (Hons.)/ LL.M.’ before the applicable deadline as per the Admission Counselling Calendar of CLAT 2026.

In case the documents submitted are incomplete or the candidate fails to upload the required documents on time, the University shall reject the candidature of such candidate on the CLAT Portal.
