With reference to the **University Grants Commission (UGC)** circular No, F.2/71/2022 (CPP-II) (C-114546) dated 12th June 2024, issued for the academic year 2024-25.

This will be applicable for the new admission **for the LL.M Regular programmed 2026-27**, unless otherwise specified. The fee refund policy is applicable for LL.M one year regular 2026-27.

The last date of the admission is 31<sup>st</sup> October 2026 for the Academic Year 2026-27.

Category	Percentage of Refund of fees	Point of time when notice of withdrawal of admission is received in the HEI	Date of the refund
1.	100%	15 days or more before the formally notified last date of admission.	For withdrawal requests received before 17 <sup>th</sup> October 2026 100% University fee refund will be given.
2.	90%	Less than 15 days before the formally notified last date of admission.	For withdrawal requests received between 17 <sup>th</sup> October 2026 to 31 <sup>st</sup> October 2026 a 90% refund will be given.
3.	80%	15 days or less after the formally notified last date of admission.	For withdrawal requests received between 01 <sup>st</sup> November 2026 to 15 <sup>th</sup> November 2026, an 80% refund will be given.
4.	50%	30 days or less, but more than 15 days after formally notified last date of admission.	For withdrawal requests received between 16 <sup>th</sup> November 2026 to 30 <sup>th</sup> November 2026, an 80% refund will be given.
5.	00 %	More than 30 days after formally notified last date of admission.	No refund will be given for withdrawal requests received after 01 <sup>st</sup> December 2026, including cases where admission is granted against a vacant seat.

- In case of withdrawal or cancellation of admission, the request for refund must be sent to [admission@mnlumumbai.edu.in](mailto:admission@mnlumumbai.edu.in), along with the duly filled and signed withdrawal form and all necessary supporting documents attached.

The date of cancellation/withdrawal mentioned on the withdrawal form shall be considered the official date for processing the request.

Please note that no interest shall be paid on the refund of fees under any circumstances.

The refund will be initiated within **45 working days**.

➤ **Hostel and Transportation Fees:**

- Hostel fees will not form part of the main academic fee structure. The hostel fees will be notified in due course
- The deadline for payment of Hostel and Transportation fees is **31st July 2026**.
- Hostel and Transportation fees for the semester shall be charged for the **entire semester**,
- Students who wish to cancel their Hostel and Transportation subscription on or before **31st August 2026** shall be eligible for a **100% refund**.
- No refund shall be paid for cancellations made **after 31st August 2026**, irrespective of the number of days attended.

➤ **IMPORTANT:**

Students joining after **31st August 2026** will be charged the **full Hostel and Transportation fees**.

➤ **Refundable Deposits:-**

Refundable deposits shall be returned in full, subject to submission of a No Dues Certificate duly cleared by the Academic Department, Hostel, Library, Administration, and Accounts sections.

- **Admission Processing Fee (Non-Refundable):** In the event of withdrawal of admission by a candidate, at any stage and for any reason whatsoever, an amount of **₹5,000/- (Rupees Five Thousand only)** shall be deducted as a **non-refundable Admission Processing Fee** from the University fee paid. The balance amount, if any, shall be refunded in accordance with the University's Fee Refund Policy.

- In case any required document is not available with the candidate, an **Undertaking in the prescribed format** must be uploaded along with the other documents.

- **PLEASE NOTE:** Candidates are required to bring all original documents for verification. Candidates who fail to submit the required documents at the time of physical document verification their **admission will be cancelled**.
