After having an excellent practice in the bar for two decades, he was elevated to the bench as an Additional Judge of Bombay High Court in the year 1978. He was appointed as the Chief Justice of Karnataka High Court on 28th July, 1995. He was a Judge of exceptional calibre and high repute. He stood for principles and values both in professional as well as personal life. Justice M. L. Pendse Foundation has established a Chair in Environmental Laws in his memory. Several outreach activities and awareness programmes are undertaken by the Maharashtra National Law University Mumbai under the banner of the Chair.

- All submissions must be in the Microsoft word Format with a one-inch margin on all sides.
- The text must be in Times New Roman with font size 12 and line spacing of 1.5.
- Footnotes must be in Times New Roman, font size 10 with single line spacing
- Citation Style: Bluebook 20th Edition style of citation should be followed throughout.
- Word Limit: 4000-4500 words (excluding footnotes).
- Research Papers should be written in the English Language

OTHER GUIDELINES

- All submissions must be original and unpublished work of the author/s and should not have been submitted, accepted or published elsewhere.
- Co-authorship of entries (maximum two) among individuals from the same or different institutions is allowed. Multiple entries same authors are not allowed.
- Articles will pass through blind peer review and acceptance will be subject to the report of
 the peer review team. Submissions not meeting the requirements mentioned will not be
 reviewed. The Editorial Board reserves the rights to accept and reject the submissions at
 any stage of the review
- Citations are required and the links to the citations should be added along with it. Authors
 may include links of rich media in their submissions as well, including embedded media
 like Tweets and video.
- Articles found plagiarized will be summarily rejected. Plagiarism > 10% will be a ground for rejection.
- Papers can be presented in absentia also without any additional charges.
