I. Definitions

- "Competition" shall refer to the MNLU Mumbai- Yuvak Biradari (Bharat) International Policy Drafting & Presentation Competition, 2025.
- "Organizing Committee" shall refer to the Organizers of the said competition.
- "Rules" shall refer to the Official Rules of the Competition and shall apply to any supplementary Rules published by the Organizing Committee.
- "Team Code" refers to the unique code allotted to a Team after the completion of their registration process.
- "Written Submission" refers to the Submission of the Policy Draft.
- "Host University" refers to Maharashtra National Law University, Mumbai.

II. General Instructions

- Mode of the Competition: Hybrid
- Mode of Submission: Online
- Mode of Presentation: Online / Offline [Offline presentations will be hosted at the premises of MNLU Mumbai]
- Participants opting to visit the campus for presentations must note that accommodation will not be provided by the host university.
- Any request to postpone the registration date and submission date will not be considered.
- Please note that all correspondence must be made with the email address provided in the registration form of the first participant.
- Failure to adhere to any guidelines may result in disqualification and/or penalties imposed on the participants.







III. Eligibility & team composition

- The competition permits participation from students enrolled in the UG/PG programme of any discipline.
- Individuals or a team of 2 members may register for the competition.
- Note that cross institution teams, meaning teams comprising members from different institutions are permitted to participate in the competition.

IV. Registration Process

- Final Registration for the competition shall be done on the following google form: Registration Form
- All interested students shall be required to register and pay the prescribed fee for the competition before the deadline, in order to be eligible to participate.
- The registration fee for an individual is INR 500/- (Rupees Five Hundred Only) and for each team is INR 1000/- (Rupees One Thousand Only) per team. The same shall be non-refundable.
- Payment for the registration can be made on the following link: <u>Payment</u>
- The Registration shall be deemed to be successful only when the participating team receives a confirmation mail along with their team code from the Organizing Committee.
- Request for any change in team composition will not be considered.
- Registration is to be done through the link provided. The deadline for registration is 05th April 2025 by 11:59 PM.







V. Submission Guidelines

- Language: Participants are permitted to choose English or Hindi as the language for the policy drafting and presentation.
- Formatting Guidelines: Font: Times New Roman, Size 12 (Main Body); Size 10 (Footnotes). Line Spacing and Alignment: 1.5 (Main Body), 1 (Footnotes); Justified.
- Citation style to be followed is the 20th Edition Blue Book format.
- Any form of identification mark of the participants on the draft policy except the 'team code' (including any disclosures relating to their institutions) is strictly prohibited and may lead to disqualification.
- Submission made by the participants is to be titled TC- 'assigned code' Policy Draft.
- All clarification requests must be submitted via the aforementioned email and within the deadline set by the organizers.
- Similarity beyond 10% shall be subject to penalties.
- Cross plagiarism is not permitted. Cross plagiarism occurs when two or more drafts share 40% or more similarity, whether intentional or unintentional. This includes copying or reproducing substantial content across submissions and will result in the disqualification of all involved participants.
- Written submissions will be screened for AI-related plagiarism. Any submission found to be predominantly AI-generated without sufficient human input or originality will be disqualified.
- File submission must be made in both Word-Docx. & PDF Formats.







VI. Objective Deductions

- Late submission: 1 mark deduction per hour and no submissions will be accepted after 24 hours.
- Non-compliance with formatting guidelines: 0.5 marks for each error up to 5 marks.
- Non-compliance with language requirements: Disqualification
- Exceeding plagiarism limits: Penalty or Disqualification at the discretion of the Organizing Committee.

VII. Review Process

- The participants will hold all the rights over their draft after the competition ends.
- The Organizing Committee is entitled to amend the Competition Rules, including the Competition format, with prior intimation to cater to any and every contingency that may arise before or during the progression of the Competition. The decision of organizers is final and binding.

VIII. Presentation Rules

- Each participant/team will have 10 minutes for presenting their policy draft, followed by 5 minutes for questions.
- Participants willing to present their policy draft via a PowerPoint Presentation (PPT) must submit the same via email (on mnlumumbaievents@mnlumumbai.edu.in) by 11th May 2025.

IX. Copyright Over Written Submissions

• The participants retain the rights over their policy drafts. However, the Host University reserves the right to publish, distribute, or use the submitted drafts for academic, research, and promotional purposes with due credit to the authors.







x. General Policy Structure Guidelines

- Participants are advised to follow the given structure while drafting their policy, however the same shall not be mandatory:
- i. Title: The title should be concise and indicative of the policy's subject matter.
- ii. Introduction: Briefly explain the context, background, and need for the policy.
- iii. Objective: Clearly define the aim and purpose of the policy.
- iv. Scope & Applicability: Outline who and what the policy covers.
- v. Legal & Policy Framework: Provide references to relevant laws, regulations, and policies supporting the proposal.
- vi. Key Provisions: Explain the main components of the policy, including its implementation mechanism.
- vii. Implementation & Enforcement: Detail how the policy will be executed and monitored.
- viii. Expected Impact & Feasibility: Discuss the practical aspects and potential benefits of the policy.
- ix. Conclusion & Recommendations: Summarize the key takeaways and suggest improvements or follow-up actions.
- x. References & Citations: Include any legal or academic references used in the draft.

- 1. Title:
 - A concise, relevant title.
- 2. Abstract:
 - Summary of the policy draft.
- 3. Statement of Problem:
 - Concise identification of the issue.
- 4. Definitions:
 - Clarification of technical terms.
- 5. Stakeholders:
 - List of impacted parties.
- 6. Policy Statement:
 - Key provisions and applicability.
 - Special conditions and exclusions.
- 7. Implementation Procedure:
 - Stepwise approach to execution.
- 8. Cost-Benefit Analysis:
 - Expected costs and anticipated benefits.
- 9. Concluding Remarks: Summary and future roadmap.


