#### **Essential Features of Required Accommodation**

- 1) The building/Hostel should be able to accommodate **600 students**.
- The building should be used exclusively for the hostel accommodation of Maharashtra National Law University Mumbai.
- 3) Each room should preferably accommodate 2 to 4 students, depending on the size of the room.
- 4) The accommodation should have well-ventilated and airy rooms with the habitable condition, a hygienic environment, neat and clean.
- 5) Toilets/Bathrooms should be attached in a room in the ratio of 3-to-1-unit, ample number of washbasins, bathrooms, and toilets in good and hygienic condition be available in the building for the students.
- 6) The rooms should be of adequate size with sufficient tube lights/LED lights and fans.
- 7) Electricity and potable water for drinking, bathing and cooking, must be available round the clock.
- 8) All the sanitary and water supply installation connections must have been available round the clock.
- Electrical installation and fittings like power plugs, switches, charging points etc. must be in place.
- 10) Emergency power backup/ generator facility should be available.

11) The building should have suitable provision and adequate space for a food facility for 600 students.

12) The selected party shall be required to execute an agreement containing detailed terms and conditions with Maharashtra National Law University Mumbai.

13) The agreement shall be signed for a period of ONE year which may be extended for a further period on mutually agreed terms and conditions on the satisfactory report of the students and authority. The agreement may be terminated by either party on giving a notice of 3 months to the other. 14) Building offered must be free from all encumbrance, claims and legal disputes etc.
15) The electricity and water supply lines/ connection shall be provided by the owner/ service provider at his own cost and expenses. Agreement building should have all the safety features and with safety certificates.

16) MNLU Mumbai reserves the right to consider/reject any such proposal without assigning any reason. In case of rejection of application, the decision of the competent authority will be final and binding and the party shall not be entitled to any compensation whatsoever for non-issue of work.

17) The decision of the MNLU Mumbai will be final in case of any dispute arising in the implementation of the terms of the contract.

24) Termination: The Agreement may be terminated by giving three months' notice by the either party to the Agreement. However, during such notice period the building /accommodation along with all ongoing facilities shall remain in the possession of MNLU Mumbai.

25) Eligible vendors are requested to submit their offer in a sealed envelope.

26) All requisite information should be filled up in the prescribed form. The filled application form, relevant information and required document should be clearly readable and all the pages of the documents should be signed by the authorized signatory of the vendor.

27) Sufficient number of washing machines shall be provided to all students 24X7.

29) Wi-Fi internet connectivity shall be provided to all the students 24/7.

30) There shall be a Hot water service for bathing for all the students 24/7.

31) All maintenance and repair of the building shall be with service providers only.

32) There shall be a Library/Reading room with at least a seating capacity of 1/3 of the total number of students.

33) There shall be adequate space for parking buses and staff/student vehicles.

34) Lift/Lifts, if any, shall be operational in good condition. A building with more than 10 floors shall have a liftman for 24X7.

35) Any of the above conditions mentioned here, may be relaxed at the discretion of the university.

36) Any additional amenities/facilities available in and around the building of the hostel can be attached with additional **annexures**.
