Maharashtra National Law University Mumbai, established under the Maharashtra National Law University Act 2014 on 20th March 2014, is one of the premier National Law Universities in India. The Act envisaged to establish National Law University in Maharashtra to impart advanced legal education and promote society oriented research in legal studies for the advancement of societal life of the people in the country. The prime goal of the University is to disseminate advance legal knowledge and processes of law amongst the students and impart in them the skills of advocacy, legal services, law reforms and make them aware and capable to utilize these instruments for social transformation and development. To attain this goal it has started its first academic endeavour on 1st August 2015.

The University offers BA.,LL.B.(Hons.) five years integrated program and one year LL.M. program in Corporate and Commercial Laws and planning to add more specializations from new academic year. Since its inception in 2015, the University has made serious and sincere efforts to excel in the field of legal research and education. Within the span of four years the University has been able to traverse an arduous yet, promising path filled with lots of possibilities for the future. Located in the pristine Powai region of Mumbai, the University enjoys an un-paralleled avenue for higher studies especially in law and related matters. LL.M. (Professional) Programme

Maharashtra National Law University Mumbai is a premier Law University established in the commercial capital city of India. The University invites applications for admission to the One year LL.M (Professional) Programme for the Academic Year 2019-20, commencing from October - 2019.

LL. M (Professional) shall not qualify a candidate to the academic benefits of regular LLM degree like admission to M.Phil./Ph.D. It shall not provide eligibility for NET/SET/SLET Exams.

Eligibility:

The LL.M. (Professional) Programme will be conducted through a mixed mode of class room teaching & virtual contact learning. A person who has completed his/her LL.B. (3 years or 5 years) and has been in service or had professional experience will be eligible to enroll for the saidprogramme.

Total number of seats

The total numbers of seats are 100. However, the University reserves the right to alter the number of seats for the programme in a given academic year without prior notice.

Note: (*Reservation: As per Maharashtra Government Rules.*)

Admission Criteria

Candidates for admission will be selected on the basis of percentage secured in LL.B. The merit cut-off list will accordingly be prepared for admission. Reservation is as per Maharashtra Government Rules.

Fee/Payment:

1. Rs.75,000/- (Rs. Seventy-Five Thousand only) for Indian students.
2. USD 1500/- (USD One Thousand Five Hundred only) for Foreign Nationals.
3. RS.3000 Fees shall be charged separately for re-registration, repeat exams etc.

Note: Being a professional program there is no consideration for differential fees to any category.

Application Fees/Payment:

Furthermore, the application fees/payment of Rs. 3,500/- (Rupees Three Thousand and Five hundred only) for General Candidates, Rs. 1,500/- (Rupees One Thousand and Five hundred only) for reserved category to be paid online only. Duration of the programme and lectures

The programme will be for a period of one academic year. The academic year will run from **October to September 2019**. The intense academic activity during each semester will be spread across 18 weeks and it shall include teaching, project assignments, seminars etc.

Note: Classes will be preferrably conducted on Saturday/Sunday / Public holidays as notified by the University in advance.

Attendance

The LL.M. (Professional) Programme will be conducted through a mixed mode of class room teaching & virtual contact learning. Attendance in the contact classes is an important component of the programme. It is expected that students shall attend the scheduled contact classes.

Attendance Every student has to secure a minimum of **50% attendance** in all the subjects taken individually in each Semester to be eligible to appear in the End-Semester examination. Student, who falls short of requisite attendance, shall not be permitted to take the end of the course/ end Semester examination.

Course Outline

The LL.M. (Pro) Curriculum will have the following components.

Compulsory and Elective Papers (**7+1 course and each course has 3 credits**)

The Compulsory Course consist of the following 7 Course and one elective Course, which should be completed in the first and Second semester.

Credits

The Programme will be of Twenty-Four (24) Credits comprising of

- i. Seven mandatory courses of **three (3) credits** each
- ii. Elective paper (**3) credits**

Course as follow (Compulsory):

- (a) Constitutional Law
- (b) Corporate law
- (c) Intellectual Property Law
- (d) Criminal Law
- (e) International Law
- (f) Law of Taxation
- (h) Cyber Law

To begin with, the following **Electives Course** will be offered:

1. Alternative Disputes Resolution
2. Human Rights
3. Environmental Law
4. Banking law
5. Insurance Law
6. Insolvency and Bankruptcy Code
7. Merger & Acquisition Law
8. Investment Laws
9. Realty Laws
10. Sports Laws

The MNLU MUMBAI may at its discretion alter the scheme and structure of Electives depending on availability of Resource Persons, number of Applicants and other factors in the interest of the efficient conduct of the programme.

Examination Scheme:

It shall be mandatory for every student to appear for every examination conducted by BOE, MNLU MUMBAI. A student who absents himself/herself for an examination shall be declared “Failed” in that course. He/she shall appear in Examination for that course, when conducted the next time. If he/she passes the course in the next attempt, the grade obtained shall have ® mentioned against it in the transcript.

Benefits of the programme are as Follows:

- A) Update the subject knowledge through contemporary advancement in law and administration of justice and allied matters.
- B) To assist in giving them an upper edge in their respective profession through multidisciplinary exposures to various laws relevant in contemporary times.
- C) Can be considered for internal growth by respective organizations as per their internal policies.
