Role and Responsibilities:

The Research Assistant shall work under the guidance of Chair Professor - Justice M. L. Pendse Chair on Environmental Laws- :

- (i) Conduct Environmental Laws related research in relevant areas as directed;
- (ii) Provide research assistance to Justice M. L. Pendse Chair on Environmental Law, MNLU Mumbai as and when required;
- (iii) Develop, plan, execute, monitor and report Environmental Laws research in collaboration with external universities, institutions, government departments, industrial and economic agencies, judiciary within India and abroad;
- (iv) Participate in overall planning and development of research, training and extension programs in the University;
- (v) Perform any other duties including administrative, coordination, etc. as required to achieve the aims and objectives of the Chair.
- (vi) Any other work assigned by the University.
