Level of Participation:

The participants shall be Ph.D. scholars/candidates admitted this year for the program along with 20 outside research scholars/academicians. In total approx.30 participants shall avail this benefit of understanding legal research with Software usage from few of the best experts in the field of research. This coursework cum workshop will be advantageous not only to the new scholars but also for academicians pursuing their doctorate.

The proposed training interaction is geared to achieve the following objectives:

- 1. To familiarize the participants about the construction and application of research methodology linking it with the formulation of a comprehensive research proposal.
- 2. To highlight the prevailing trends in computer applications in legal research.
- 3. To develop the skill among the participants to use SPSS/MS

 Excel/Statistical/ software for data analysis in socio-legal research.
- 4. To use other software in data analysis and presentation.
- 5. To apprise the participants about use of statistical techniques in data analysis through software.
- 6. To apprise the participants about the e-learning in legal spheres, use of selected legal database and other online information useful in the conduct of research
- 7. To expose the participants to jurimetrics and recent initiatives in E-court initiatives.
- 8. To develop the skills of preparation of research proposals encompassing all the phases of a research exercise.
