A. Teaching Position (Self Finance-Regular Scale)

1. Associate Professor (Law) Category –Open -01

➤ Eligibility:

A) Essential Qualifications: -

- Good academic record with a Ph.D. Degree in the concerned/allied/relevant disciplines
- A Master's Degree in Law with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) from any recognized University or an equivalent degree from any foreign University.
- A minimum of eight years of experience of teaching and / or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry with a minimum of seven publications in the peer-reviewed or UGC-listed journals and a total research score of Seventy-five (75) as per the criteria given in Appendix II, Table 2 of UGC Regulations, 2018. (enclose proof)
- A minimum score as stipulated in the Academic Performance Indicator (API) based Performance Based Appraisal System (PBAS) of UGC.

B) Desirable Qualifications: -

- Demonstrated academic and research expertise in the field of Mergers and Acquisitions, with a strong foundation in Corporate and Commercial Law.
- Proven teaching and research experience in areas such as:
 - Corporate Restructuring and M&A Transactions
 - Securities Regulation and Corporate Governance
 - Competition Law implications in M&A
 - Due Diligence and Transactional Documentation
 - Cross-border M&A and Foreign Investment Laws
- Evidence of published research in reputed peer-reviewed journals or edited volumes focusing on **M&A law, corporate finance law, or transactional law**
- Experience in supervising postgraduate and doctoral research in the field of **corporate transactions, business structuring, or financial regulation**.
- Practical exposure to M&A transactions through consultancy, legal practice, or advisory roles (desirable).
- Familiarity with national and international regulatory frameworks, including SEBI regulations, Companies Act, Competition Act, and relevant FDI policies.
- Participation in academic, regulatory, or policy initiatives related to **corporate restructuring, takeover regulations, or financial sector reforms**.

2. Assistant Professor – (Maritime Law) (Category – Open -01)

➤ Eligibility:

A) Essential Qualifications: -

- A Master's degree with 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in a relevant subject from an Indian University or an equivalent degree from an accredited foreign University.
- Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances / Byelaws / Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET / SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities / Colleges / Institutions subject to the fulfillment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences /seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

B) Desirable Qualifications: -

- Demonstrated academic and research expertise in Maritime Law, with a strong understanding of national and international legal frameworks governing maritime activities.
- Proven teaching and research experience in areas such as:
 - a. Law of the Sea and UNCLOS
 - b. Admiralty and Shipping Law
 - c. Marine environmental law and coastal regulations
 - d. Maritime safety, security, and port regulations
 - e. Carriage of goods by sea and marine insurance
- Evidence of high-quality publications in reputed peer-reviewed journals or edited volumes in the field of **Maritime Law, International Trade Law, or Environmental Law**.
- Experience in supervising postgraduate and doctoral research in **maritime law, international commercial law, or ocean governance**.
- Familiarity with legal regimes such as **UNCLOS, IMO conventions, Indian Merchant Shipping Act**, and other relevant maritime statutes and international treaties.
- Engagement with maritime institutions, regulatory bodies, or participation in legal advisory roles related to **shipping, navigation, or ocean governance** (preferred).
- Interdisciplinary exposure to maritime policy, international relations, or marine environmental studies will be an added advantage

NOTE:

- The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.
- NET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SET. However, Ph.D. degree shall remain the minimum eligibility for appointment of Assistant Professor in such disciplines.

OR

- The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following:
 - i. Quacquarelli Symonds (QS)
 - ii. the Times Higher Education (THE) or
 - iii. the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

Note: The Academic score as specified in Appendix II (Table 3A) for Universities, and Appendix II (Table 3B) for Colleges, shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the interview.

3. The application fees of Rs. 500 /- (General Category) & Rs. 250/- (Reserved Category) shall be paid through online mode. Application Fee will not be refundable.
4. 6. Print out of application made in the prescribed format through online mode only will be considered by the University. Applications in other forms such as Bio-data, C.V. and any other offline application will not be considered.
7. Candidates shall affix a passport size photo on the application.
8. Application form shall be accompanied with self-attested copies of the following documents:
 - i. Documents related to educational qualifications, such as Degree/ Diploma certificates, Statement of Marks, other certificates of the relevant examinations (both side photocopies of the Statement of Marks) and any other certificates relating to the educational qualifications.
 - ii. Certificate/s of teaching/ administrative experience issued by the competent Authority.
 - iii. Approval letter/NOC in case of teachers appointed in affiliated colleges/ recognized institutions
 - iv. Birth / SSC certificate or other Government document as a proof of date of birth
